

TRYOUT REQUIREMENTS

Age groups are as follows:

- **Cubs**: Ages 6-9 (6 by Dec. 2018)
- **JV:** Ages 9-12 (9 by Dec. 2018)
- Varsity: Ages 12-16 (12 by Dec. 2018)

CLINIC AND TRY OUT FEE

- All applicants must be present for both clinics in order to tryout.
- \$60.00 -Clinic/Tryout fees are due the first day of clinic.
- All paperwork must be turned in the first day of clinic.
- Those candidates that do not arrive on time will not be allowed to stay for clinic.
- Tryouts are closed. No cameras, video cameras or cell phones will be allowed.
- Applicants of the highest score will be chosen by the advisors/judges.

CLINIC / TRYOUT ATTIRE

- Black or Green shorts, white shirt.
- Tennis shoes must be worn.
- Hair in a ponytail with a cheer bow.
- No jewelry.
- Returning students to PYC cheer must NOT wear anything signifying their affiliation to the team.

JUDGING PROCEDURES

- Applicants will tryout in groups depending on numbers of applicants no more than 3 to a group.
- All applicants will be taught a competitive spirit cheer and dance to be performed in front of three judges.
- Applicants will be asked to show a jump of their choice.
- Applicants can show any tumbling skills that they have mastered.
- Applicants will be rated on the basis of the following criteria: (100 points) appearance, jumps,cheer, dance, technique, execution,showmanship, recoveries, routine execution, participation and crowd leading.

SELECTION PROCESS

- The squads will consist of three separate squads: Mascots, JV and Varsity
- Squad sizes will be based on a break in the scores. The Advisor/Coaches will determine the break and/or the final number in each squad.

Final selection will be based on:

- Participation and attitude at clinics and tryouts by daily evaluation by Advisor/Coaches
- Ability to follow and execute directions: daily evaluation by Advisors/Coaches
- Ability to execute the cheer and dance taught to them.
- Panel judging: including technique, spirit, and leadership
- The panel for judging will consist of 3 judges.
- The scoresheets are tallied by an employee and Coaches.
- Scoring will be **confidential** and there will be no exceptions.
- All applicants will be notified of the acceptance on the individual squad which they auditioned for through email on application on Friday, May 11, 2018 in the evening. (After 9:30 pm)
- If an applicant doesn't make the team they tried out for, they may be placed in a different squad.
- If an applicant does not make a team they can sign up for the Advanced recreational team until the next tryouts and can ask for suggestions on how to improve for our next year tryouts.

ALL scores are final. Please understand that they are not up for discussion or re-consideration.

TUITION AND OTHER EXPENSES

TUITION FEES

• Tuition only will be paid in 6 monthly installments per athlete for all teams.

Tuition includes:

- All Team practices, Pacific Youth Cheer Recreational performances, and Competitions for athletes only.
- Additional practices and specialty classes may be added to the schedule and will be an additional fee.

ALL SQUADS - \$1875

Includes: Tuition/5 Performances / 6 Competitions/1 Champs/ 2 Stunt/Tumbling Clinic and the Banquet. **Family members are responsible for paying their own entrance fees for Competition, Performances, and Banquet.

POLICIES & GUIDELINES

Teams will consist of a min. of 5 members. Applicants of the highest score will be chosen by the advisors/judges.

All applicants who make the squad must have the following:

- Positive attitude towards all team members/coaches/advisors.
- Good general appearance (hair in ponytail) & Practice Uniform
- Positive and outgoing personality
- Good Sportsmanship
- Attend all PYC activities, practices, performances and Competitions.
- Arrive on time for all PYC activities, practices, performances and competitions.
- Notify advisor beforehand if late or absent. (Members can be eliminated from the squad for a total of 10 absences and/or tardiness)
- Each member must maintain a 2.5 GPA at all times to remain on the squad
- Team placement is solely determined by the advisors.
 All members are required to stay involved with the competition squad the entire season. (If a Member quits prior to the end of the season there will be a \$200 cancellation fee. (NO EXCEPTIONS)
- Participate in building team unity through group activities.
- All members must be in good health.
 (Members and parents should be aware of extensive physical requirements of being a member of the squad, including conditioning/exercising, when necessary)
- Members who have an injury or incurs an injury during the season must have a
 current medical release stating they may resume with cheer activities prior to
 practicing with the team.
- Competitive cheer is a 10 month commitment. Those wishing to participate in any
 other sport or activity that requires a substantial amount of time must first
 obtain a <u>written consent from the Director/Coaches</u>. Once the Director/Coaches
 approves the consent, cheerleading events/competitions will take
 precedence over any other activity and can be terminated from the squad if not
 followed.
- No acrylic nails or jewelry at practices, competitions and performances-for safety purposes.

- No nail polish or jewelry at all Competitions/Performances.
- Members must comply with the dress code that the advisors set forth.
 Failure to comply will result in suspension from the squad.
 - A Demerit System for unexcused absences, tardiness and behavior will be implemented once an applicant is on the team. A cheerleader may be dismissed from the team based upon this 10 point Demerit System. The director and the coaches may assign Demerits or remove some from the team at their own discretion if conduct is unbecoming to Pacific Youth Cheer as they have the best interest of the entire squad in mind. This may include but not limited to:
 Demeaning, bad mouthing, or disrespecting another team member.

 Captain, coach or Director.
 - I fully understand any misuse of social media including but not limited to Twitter, Facebook, Instagram, etc. will result in disciplinary action. Any conduct that is unbecoming of a Pacific Youth Cheer cheerleader can result in my removal from the cheerleading squad.
 - Fundraising is optional
 - Transportation: Parents are required to arrange transportation to and from all practices and competitions/ performances.
 - Parents are asked to be prompt for all drop off and pick up times

DEMERIT SYSTEM: All Cheerleaders will be held accountable throughout the year for their conduct, appearance, and attendance. A demerit system will be implemented out of the best interest of the entire squad. All parents and cheerleaders will be required to register on Team App to keep track of your demerits. If someone is conducting themselves in a manner unfit of a cheerleader, or is not making choices in the best interest of the squad you will get a demerit.

YOU WILL RECEIVE ONE DEMERIT FOR THE FOLLOWING:

- Tardiness (1- MINUTE PAST IS CONSIDERED LATE) will result in 1/2 demerit
- Acrylic Nails will result in 1 demerit
- Every D Or F (Report Card) will result in 1 demerit
- No Weights will result in 1/2 demerit
- Not returning paperwork will result in 1/2 demerit
- Not wearing complete PYC Practice Uniform will result in 1 demerit
- Missing a practice the week of a competition for any reason will result in 1 demerit and removal from the routine. (Even if on your conflict sheet)
- Missing practice, coming late to practice, leaving practice early, <u>unexcused</u> <u>absences</u> (even if they are put on the conflict sheet) will result in 1 demerit.
- Missed Performance/Event etc. will result in 1 demerit
- Missed Competition will result in 2 demerits

YOU WILL ALSO RECEIVE TWO DEMERITS FOR THE FOLLOWING:

<u>Unexcused</u> absence include: Birthdays, vacation not told at least 1 month in advance, illness without a doctor's note, homework, tutor, driving classes, doctor/dental appointments.

**Excused absences would include: Vacation/events that were told to the director/coach at least 1 month in advance, family emergency with approval by the director/coach and contagious illness with doctor's note.

CONSEQUENCES FOR DEMERITS

Upon the 5th demerit a letter will be emailed to the parents to be signed and returned.

Upon the 7th demerit a mandatory conference will be held with the director/coach, parent and cheerleader.

Upon the 10th demerit the cheerleader will be dismissed from the squad.
